In accordance with the Proclamations issued by the State of Louisiana, specifically including but not limited to JBE 2020-33 issued on March 22, 2020:

The Rapides Parish Courthouse will remain operational for our governmental agencies to continue to operate and conduct the essential functions which are necessary for the public business, health, safety, and welfare. This includes the Rapides Parish Police Jury, Sheriff's Office, District Attorney's Office, Registrar of Voters Office, Clerk of Court Office, 9<sup>th</sup> JDC Judges Office, and Tax Assessor Office.

**Courthouse Closed to Public Traffic.** However, the Public will **NOT** be allowed into the Rapides Parish Courthouse through at least April 13, 2020, in compliance with Proclamation JBE 2020-33.

**Public Options:**

**NOTE:** The public may continue to ask questions or conduct business with the public agency they need through telephone calls, email, or Internet online business.

**NOTE:** The Rapides Parish Clerk of Court will provide a drive-thru service office on the bottom floor of the Courthouse Garage for the filing of essential and necessary documents.

**NOTE:** Any person who has essential and necessary business that may **NOT** be conducted via telephone, or email, or Internet online business, may appear at the rear entrance of the Parish Courthouse between the hours of 8:30 a.m. and 4 p.m. and make a request for the specific governmental agency they need to speak directly with: the Rapides Parish Police Jury, Sheriff's Office, District Attorney's Office, Registrar of Voters Office, Clerk of Court Office, 9<sup>th</sup> JDC Judges Office, or Tax Assessor Office.

We deeply regret any inconvenience the above may cause to any of our citizens. However, these precautions are taken to protect the health and welfare of all our citizens.
